Dear Members / Parents,

The Academic Year 2018-19 has commenced and we welcome all new members. The committee also takes pleasure in thanking the existing members for their support. This year also KVSWS had taken up the task of providing uniforms, text books, note books and other accessories to the students at less than market rates. Many have availed the facilities and benefitted. If anyone is still in need of these services, they can contact KVSWS office.

As decided in the General Body meeting of PTA held on 16.07.2016 KVSWS was formed. With the concurrence of KV PTA Sub-committee for Bus Maintenance, the day-to-day operations of school bus service is being overseen by KVSWS which is committed to see the successful operation for the benefit of the students. However, majority of the parent members are unaware about the problems faced in the operation. The buses are very old and require frequent and heavy repairs. Rules and regulations being introduced by KV Sanghatan is stifling bus operation. Issues pertains to operational bus crews are also not much known to bus users.

As per the AGM held on 13.01.2018 under the banner of KVSWS as well as KV PTA Sub-committee for Bus Maintenance, the following resolution has been approved:

- 1. Revision of Bus fare: School bus fares were last revised at the beginning of AY 2014 15. Since then various cost involved in operation of buses has gone-up. Diesel is an important operational expenditure for running buses. Diesel price has been increased drastically since May 2014. Similarly, wages of bus crews was increased by 13 per cent in 2016 and is set to increase by this year (2018). Added to this is the increase in maintenance, insurance and other vehicle related expenditure. Hence decided and approved by the AGM to increase bus fare not less than @22% wef 01.06.2018.
- 2. Refund of bus deposit from the year 2018-19 onwards would be at the following rates: Academic year 2018-19 would be treated as the First Year for all existing members.
 - i. First two years 90% of the deposit would be refunded.
- ii. Next two years (i.e. three and four years) 80% of deposit would be refunded.
- iii. More than four years 70% of deposit would be refunded.
- 3. Online payment implemented wef 01.06.2018: Steps for online payment: —
